The sewer system which was built in 1974 has seen more and more problems in the past few years with the interceptor and main line that serves the Borough. The Borough will be doing a project to replace the interceptor from the Long property to N. Pleasant Ave, plus an 80 foot section on N. Pleasant. Most of the work will be open excavation, but some will be pipe bursting. Two manholes will also be relocated.

Easements will be needed from the homeowners in the immediate area, some temporary and some permanent. There is no cost to the homeowners. The Borough has applied for a grant in order to do the work. There should be no interruption of service and everything will be restored to conditions prior to excavation. However, trees and shrubs are not allowed on a permanent right-of-way, and will not be replaced if removed for the project.

Mike Ness, 305 N. Walnut St, stated that he had a water problem with the nearby creek. He had planted trees and regraded the area in order to stabilize the bank and rectify the problem. The sewer line runs along that area. Mr. Malesker told him they would try to save his trees and the area would be re-graded exactly as it was. Mr. Resh said that it would be open excavation in that area and asked if he would be open to the possibility of shifting the sewer line away from the creek. Mr. Ness said he would and will call the Borough office to schedule a meeting with the engineers at the site to discuss further.

The Right-Of-Way agreements were available for any of the homeowners in attendance who wanted to sign. Notary, Yvonne Schrum, was also present in order to notarize the agreements at no cost to the homeowner.

## YORK AREA REGIONAL POLICE DEPARTMENT REPORT - Report given by Sgt. Good

- Crime was low in the Borough during the month of November. There were 4 traffic accidents, 21 traffic citations, 57 miscellaneous calls and 14 offenses. The Borough's hours of service is over by 120.
- The department has two new recruits which just graduated from the academy and another that just finished his probation.

# FIRE COMPANY REPORT – Report given by Chief Patrick Noll

- There were a total of 51 calls during the month of November with 9 being in the Borough. There was no loss.
- The Fire Police responded to 8 calls during November for a total of 48.57 man hours. They also had 1 non-emergency event for a total of 10 man hours.

It's a possible mechanism to not renewing a rental permit. Council asked that Attorney Ruth move forward with drafting a similar ordinance for Dallastown Borough.

# **ENGINEER'S REPORT**

- The scope of the upcoming sewer project was reviewed at the earlier meeting. The residents that were
  present at that meeting signed the Right-of-Way, but not all of the residents affected were present. The
  project will continue moving forward.
- The Chapter 94 Report is complete.

# **BUSINESS FOR ACTION**

Councilwoman Karen Hoyt-Stewart has sold her home and moved out of the area. She submitted a
letter of resignation to Council. Council now has 30 days to find a replacement to fill the position. All
letters of interest must be received at the Borough Office no later than 4:00 PM on January 5, 2017. The

requirements are; having lived in the Borough for at least 1 year and being a registered voter. Council will appoint a replacement at the next Council meeting on January 9, 2017. One letter of interest has already been received.

• Arthur Wertz has submitted his resignation from Dallastown-Yoe Water Authority. He has served on the Authority for 15+ years.

**Motion:** Mr. Liesman moved and was seconded by Mr. Metz to accept Mr. Wertz's resignation from Dallastown-Yoe Water Authority with regrets.
