ENGINEER'S REPORT

- HRG received updated plans for the Heather Glenn Development from Burkentine Builders. One concern is Burkentine does not want to loop the water main as requested by DYWA and HRG. HRG will request documentation from Burkentine Builders stating why they cannot loop the water main. Mr. Ruth stated if the documentation is not sufficient DYWA has the right to make them loop the main.
- HRG submitted the application for the CFA PA Small Water and Sewer Grant. The project consists of replacing 700ft of galvanized main on E Howard St in Yoe and replacing 1200ft of lead main on Mockingbird Dr in York Township. The amount request was \$419,020. HRG looks for the grant to be awarded in early 2026.
- Mrs. Hartz presented the formal capital improvement plan proposal to DYWA members. DYWA will look over the proposal and discuss it at the October meeting.

SOLICITOR REPORT

 Burkentine Builders has asked DYWA to take dedication of the water infrastructure in the finished section of Hudson Ridge. Mr. Joines had given them a list of repairs that needed to be completed before DYWA would accept the dedication. Burkentine is still working on the punch list.
