- I.K. Stoltzfus started an in-service visual tank elevation inspection on all 4 water tanks. Mr. Joines should have the report for the October DYWA meeting.
- Mr. Mendinsky stated the CFA LSA program opened 9/1/24 and would like to work with DYWA staff to come up with projects that would qualify for the grant. Applications are due by 11/30/2024.

SOLICITOR’S REPORT

- Burkentine Builders has asked DYWA to dedicate the water lines in the finished section of Hudson Ridge. Mr. Joines has given them a list repairs and inspections that will need to be done prior to the dedication.
- Verizon increased the amount for the new lease agreement from \$1500.00 to \$2500.00 per month. This would not begin until 2030.
